Rocio Bernales operates a family child care in the rural town of Parlier, in Fresno County. The families in this farming community rely on the flexibility of her programs because their hours are long, and their work can be seasonal.

“Our town government required us to make expensive property upgrades in order to run our child care program. We did what they asked, but the extra cost meant we had less money for materials for the kids in our care,” said Rocio.



The Parlier Finance Director explained the problem in an interview with The Business Journal: “The issue was that local municipal codes in Parlier require water backflow devices in businesses, and that was in conflict with a state law that exempts child care facilities, even if it’s a home.”

The Child Care Law Center, representing the child care providers, asked the city to eliminate the local fees and reimburse the residents. Our staff negotiated with Parlier officials to refund approximately \$23,000 to sixteen child care providers. Each child care provider has received between \$700 and \$2,000.

“This reimbursement will help pay for my classes to be a better teacher, and give a better education to the children in my care,” said Rocio.
 “I am so happy and thankful about this result.”

As a young mother and college student, Tiffany needed child care to continue her education. She signed up for the state program that assists low-income parents with child care costs so they can finish their education. But unfortunately Tiffany – like thousands of parents each year – lost her affordable child care because of a technical problem in the transfers between state agencies.

We showed lawmakers how to legally fix this problem. Thanks to your support, we make sure policies actually work for families.

IN CHILD CARE THEY LOVE!

Tariq is a precocious three-year old who was ready for preschool – and his mom, Leila, was looking forward to working full-time again at the job she loves. She found Tariq a place where he would thrive: a preschool right by their house with loving teachers and an enriching program. But she faced a setback when the preschool administrators told her they were not allowed to give Tariq his insulin.

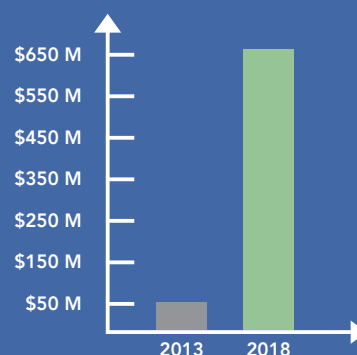

PAULA K. MATHIS

What are your strongest beliefs about child care and preschool?

My strongest belief is that when talking about making our communities stronger and more equitable, **child care is the place to start**. Quality child care increases the chances that children will be healthy adults. Also, having reliable child care reduces stress on families.

How has having child care changed your life?

When I took my son to child care so I could work, I chose the closest one to my home. It was a great experience—I knew he was in safe care, and had fabulous activities. Their excellence was an asset to me as a parent. Before that, I had never thought about the difference between child care and babysitting. It made me very interested in working to make quality child care available to everyone.

How have you seen quality child care impact the children in your community?

I was on the Board of the Head Start in Orange County for many years. I saw kids who had never had any formal care, who would then leave the program after a year and be ready for kindergarten. Every child should get that opportunity.

Why do you support the Child Care Law Center?

The work that the Law Center does is foundational. Their success not only changes individual lives, but changes communities.

The more I learn about what they do and where they make an impact, the more convinced I am that they are doing the most important work for children, families, and providers.

And once I got to know the staff, I was even more impressed with their knowledge, commitment and drive to make things better for our most vulnerable children and our communities.
